(Priority for OSCE participating states and partners for cooperation)

TICA : Thailand International Cooperation Agency
is a national focal point for Thailand's international development cooperation. TICA was established in 2004 to realize Thailand's aspiration to be a contributor of development cooperation. Believing that global challenges are best addressed by international cooperation and global partnership, today we continue to strengthen our contribution to achieve global development agenda through various capacity-building and human resources development programmes. In response to the recent changes in the global landscape of development cooperation, especially through the concept of South-South and Triangular Cooperation, TICA continues to realign our focuses in order to deliver Thailand's commitment to be a relevant partner in global agendas including the 2030 Agenda for Sustainable Development.

AITC : Annual International Training Course
was initiated in 1991 as a framework in providing short-term training for developing partners. Today, the AITC remains one of TICA's flagship programmes. Aiming at sharing Thailand's best practices and experience to the world, the AITC training courses focus on development topics of our expertise currently categorized under five themes namely, "Sufficiency Economy Philosophy" or SEP, Food Security, Public Health, Climate Change, and Other topics related to Sustainable Development Goals (SDGs).

National Institute of Development Administration (NIDA)

The National Institute of Development Administration (NIDA) was established in 1966, following His Majesty the late King Bhumibol Adulyadej's vision of advancing Thailand's development through the establishment of an advanced educational institution to prepare people to become agents of change for national development. This training course is to be organized in cooperation by Siripattana Training Center and Center for Research & Development of Disaster Prevention & Management

AITC Theme : Climate Change

This training course falls under the AITC theme – "Climate Change". We believed that Climate Change is one of the most serious and pressing global challenges with momentous consequences if left unattended. Therefore, strengthening resilience and adaptive capacity to climate-related hazards and natural disasters is crucial to sustainable future. The AITC courses under the theme "Climate Change" are part of Thailand's commitment to work with the international community to achieve SDG goal # 13 on Climate Action.

Course Objectives

This training course aims at raising awareness of clean technology and low industrial waste to promote eco-industry. At the end of this course, participants are expected to;

- Understand clean technology with the benefits of releasing low industrial waste under the context of Eco-industry.
- Understand process of recycling industrial waste.
- Understand significance of BAT/BEP concept under the context of UNIDO and be able to apply this knowledge to industrial sector of his/her own country.
- Gain awareness on the toxicity of dioxins and polycyclic aromatic hydrocarbons
- Be able to interpret toxic chemicals released from each type of fuels including their heat efficiencies.
- Be able to provide the knowledge of specialty associated with industrial boilers coupled with its heat efficiencies.
- Understand the public participation as one of the social tools to raise public awareness between industrial sector and local community.

Assignment and Evaluation

- In-class participation.
- Advance assignment - Submission and presentation of "Country Report" which include relevant BAT and BEP information in the context of participant's respective country.
- Reading Assignment - reading materials will be given.
- Attendance - Participants are required to attend all activities organized during the course. TICA reserves the rights to revoke its fellowship offered or take appropriate action in case a participant is in attendance of less than 90 percent of the training hours.

Course Outline

This training course focuses on Best Available Techniques (BAT) and Best Environmental Practices (BEP) for industrial boilers. Topics of the training are such as;

- Introduction to boiler technology.
- Fuels for boiler.
- Combustion analysis in boiler.
- Environmental impacts of boiler technology.
- Best Available Techniques (BAT) and Best Environmental Practices (BEP) for boilers.
- Green boiler design, operation and maintenance
- Dioxin analysis.
- Dioxin sampling.
- Community partnership.

Course Methodology

Training methodologies to be used during this training course include;

- Lecture
- Group Discussion
- Seminar
- Workshop
- Study visit

Participant Criteria

Candidates must possess qualifications as specified in "Guideline for Thailand's Annual International Training Course Programme" No. 2 "Qualifications" as well as following qualifications:-

- Currently working with experience in environmental control and management. Candidates from government/private sector are preferable.
- Graduate with university degree in science or engineering.

- Candidates must be nominated/ endorsed by their respective governments of the eligible countries/territories as well as Andorra, Australia, Austria, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Holy See, Hungary, Iceland, Ireland, Israel, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Monaco, Netherlands, Norway, Poland, Portugal, Romania, Russian Federation, San Marino, Slovakia, Slovenia, Spain, Sweden, Switzerland, The Republic of Korea, The former Yugoslav Republic of Macedonia, United Kingdom and United States.
- Complete nomination documents must be submitted to TICA through the Royal Thai Embassy/ Permanent Mission of Thailand to the United Nations/Royal Thai Consulate-General accredited to eligible countries/ territories.
